The resurgence of interest in *The Handmaid's Tale* in the context of movements like MeToo and Women's Marches further validates its relevance as a feminist text that transcends time and geography (Cranny-Francis, 2019).

## **Dystopian and Political Readings:**

Beyond feminist interpretations, *The Handmaid's Tale* fits squarely within the tradition of dystopian literature, drawing comparisons to works like George Orwell's *1984* and Aldous Huxley's *Brave New World*. In Atwood's Gilead, theocratic authoritarianism is legitimized through a distorted interpretation of Christian doctrine, underlining the dangers of religious extremism when fused with political power. According to Booker (1994), Atwood "constructs a dystopia that functions as a cautionary tale against theocratic totalitarianism."

Much like in Orwell's *1984*, citizens are constantly monitored by state agents (the Eyes), and informants are embedded within society to instill fear and compliance. This mirrors contemporary concerns about state surveillance, especially in post-9/11 security environments and digital societies where personal data is routinely collected and weaponized (Zuboff, 2019).

Politically, Gilead is constructed as a reactionary regime, born from a desire to "fix" a morally degraded society. This rise of authoritarianism under the guise of moral revival has been echoed in the rhetoric of various populist and fundamentalist movements worldwide. The novel's relevance is further underscored by parallels drawn between Gilead and modern regimes that restrict press freedom, manipulate religious identity, and curtail women's rights in the name of tradition or nationalism (Stillman & Johnson, 1994).
