This signifies what could be describe as a "third wave" of approaches within literary studies which is integrates the strength of formalist, structuralism theories alongside new area of research, including affect theory, digital humanities, posthumanism, environmental humanities, and neocriticism.

N☐ Pluralistic theoretical frameworks: modern literary criticism exhibits distinctive rang of theoretical approaches. While previous academic traditions often maintained exclusive adherence to a single framework in contrast to today plurastic methodology such as Marxism, psychoanalysis, or feminism.
This shift corresponds with wider academic and cultural trends emphasizing intersectionality and interdisciplinary approaches. It also signifies the growing emphasis on ethics in contemporary literary criticism, as scholars become more attentive to issues of justice, equity, and representation. A single literary text might now be analyzed through multiple compelling lenses, including critical race theory, ecocriticism, queer theory, postcolonialism, disability studies, and cognitive approaches to literature. Such pluralism enhance interpretation and expands the connect of literary criticism to contemporary concerns.

r. T⊔ Interdisciplinary Methodologies: The second major
development is the integration of interdisciplinary tools and frameworks. Smith highlights how digital humanities (Liu, 2018),
environmental criticism (Garrard, 2019), and cognitive science
(Stockwell, 2020) have expanded the interpretive possibilities of
literary scholarship. For example, distant reading (Moretti, 2005)
allows scholars to trace large-scale patterns across literary
corpora, revealing structural and thematic trends that
complement traditional close reading. Furthermore, insights
from neuroscience and psychology are now used to explore
reader response and narrative empathy. These interdisciplinary
innovations not only rejuvenate literary criticism but also position it within broader conversations across the humanities

Smith provides compelling examples of theory in practice,
including a posthumanist reading of contemporary science
fiction (Braidotti, 2022) that challenges anthropocentric notions

reading of Renaissance drama (Greenblatt, 2021), informed by newly discovered archival materials. Smith also explores how
feminist, trauma, and memory studies are applied to classical
and Holocaust literature. These applications show that literary
criticism is not merely an abstract endeavor—it is an engaged,
responsive, and at times therapeutic practice that seeks to
understand literature's role in reflecting and shaping human

Despite the article's strengths, several limitations merit attention. First, some sections presume a high level of theoretical familiarity (Lodge & Wood, 2008), potentially alienating readers new to the field. Second, while Smith passionately advocates for theoretical pluralism, the article pays

These models favor descriptive over symptomatic reading and encourage a renewed attention to the aesthetic and emotional dimensions of texts.

Another area where the article could improve is in its limited engagement with non-Western traditions. While Smith briefly acknowledges the need for global perspectives, there is little substantive analysis of how literary theory functions in contexts beyond the Anglo-American canon. Integrating frameworks from world literature, comparative literature, and indigenous studies would better reflect the diversity of global literary production. Scholars in the Global South, for example, bring unique methodologies that challenge Eurocentric paradigms and foreground alternative epistemologies rooted in local histories, languages, and worldviews.

Nevertheless, Smith's article remains a valuable resource for scholars and students navigating the evolving field of literary criticism. with Its historical depth, conceptual clarity, and practical insights it lays a strong ground for future research. As the humanities face increasing pressure to demonstrate relevance and social value, the integration of theory and textual analysis remains vital. Smith successfully argues that theory, far from being an abstract or esoteric exercise, is a necessary tool for understanding literature's cultural, ethical, and political dimensions.
