## *Publishing instructions in the journal of*

# **Surra Man Ra'a**

The scientific journal (Surra man Ra'a) welcomes the contribution of researchers inside and outside the country. It takes them with confident steps towards a bright future in the aspects of life, and here are some of the requirements for publishing:

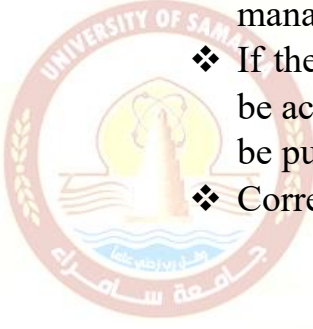
- ❖ The journal receives scientific research in all fields of human sciences.
- ❖ The editorial board evaluates the examined science with experts who have been certified objectively to draw objective judgments and comments that elevate publishing acceptance.
- ❖ The journal refuses to publish research papers that do not match the worldwide known scientific research methods.
- ❖ The researcher is obligated to take into account any notes and comment received about his/her research, through what is determined by the evaluating experts.
- ❖ The research must not have been submitted to another journal, nor previously published. As a matter of guarantee, the researcher must undertake in writing to do so.
- ❖ The following shall be recorded on the first page: (the title of the research, the precise specialty of the research, the researcher's full name, scientific title, affiliation of work, email, phone number, ORCID number, and keywords, all of these data must be provided in both Arabic and English). In case there are more than one researcher their names and addresses must be listed to facilitate the process of contact.
- ❖ An abstract for the research is printed on a separate page, in both Arabic and English, provided that it does not exceed (200) words.
- ❖ The journal adopts the APA method for scientific publishing in documentation, and the researcher must follow the rules of citation, documentation of sources, and ethics of scientific research in accordance with this system.

- ❖ Research references must be recorded on a separate page or pages arranged according to the approved principles, according to the following order:

Author's last name, author's name. (Year of Publication). The title of the book. Edition number (Ed3). Publishing House. Place of publication (city). See APA Documentation Resources. For more information (<https://www.apa.org>).

- ❖ Translate all non-English sources (including Arabic) into English, keeping the list written in the language of the research.
- ❖ In case the Arabic sources have a certified translation from the English language, it must be approved. As for the sources that do not have a certified translation into the English language (such as: لسان العرب), note that such books are translated phonetically, meaning that the source is written in English letters (Lisan Al-arab).
- ❖ The journal applies a plagiarism checking system using the Turnitin program. Thus, any research -in which the plagiarism rate exceeds the internationally accepted rate- is rejected for publication.
- ❖ Acceptance for publication does not oblige the journal to publish the scientific research within issues except what is befitting its scientific reputation.
- ❖ Research fees for researchers from inside Iraq are (100,000) IQD, provided that the number of the pages should not exceed (20) pages, including data, maps, and illustrations. If this happens, the researcher(s) must pay an amount of (5,000) dinars for each additional page.
- ❖ The research is printed on the calculator, on A4 size paper, and on one side.
- ❖ The research should be printed using (Microsoft Word) program, in (Simplified Arabic) font for research written in Arabic, and (Times New Roman) font for research written in English, in size (14) for the research body, and (16) for the main and sub-headings.
- ❖ After taking into account the evaluators' notes, a CD is attached to the corrected research according to the experts' comments.
- ❖ The research is divided into an introduction and appropriate headings that indicate it, to replace the list of contents.
- ❖ The journal is not obligated to return the research to its owner if the experts object and reject to its publication. A written apology is sufficient.
- ❖ The scientific research approach and documentation are among the features of the peer-reviewed journal.

- ❖ Correspondence should be addressed in the name of (editor-in-chief) or managing editor.
- ❖ If the research contains Qur'anic verses, the pattern of the verses will be according to the Madinah Qur'an program, and the research will not be published otherwise.
